### How we use your information

We use your information:

- To administrate and delivery the Modern Apprentice Programme
- To confirm your eligibility to enrol in the Modern Apprentice Programme
- To provide access to college systems and services
- For performance and assessment purposes
- To access funding to support the costs of the Modern Apprenticeship Programme

Our lawful basis for using this information is **contract** and **public task.** Where we process special category data, our additional lawful basis is reasons of substantial public interest, under the Equality Act 2010: DPA 2018, Schedule 1, Part 2 8 (1) – Equality or opportunity of treatment.

### **Failure to Provide Information**

If you do not provide personal information that is required by NCL for a contract or to fulfil our public task, NCL may be prevented from complying with our legal obligations and may not be able to provide you with the course for which you have applied or enrolled. In some cases, this could have an effect on your continued studies with us or lead to the withdrawal of any offer of study made.

#### International Transfer
